Cookie Policy

\$1 General provisions

 This Cookie Policy explains the use of cookies and similar technologies by the Cue Ball Network application (the 'Application') managed by CUE BALL NETWORK SPÓŁKA Z OGRANICZONĄ ODPOWIEDZIALNOŚCIĄ with its registered office in Warsaw (address: ul. Żurawia 6/12 / 745, 00-503 Warsaw, Poland). Use of the Application implies acceptance of the terms and conditions described in this Cookie Policy.

§2 What are cookies?

- 1. Cookies are small text files stored on your device (computer, tablet, smartphone) when you use the Application. These files enable the correct operation of the Application and improve the use of its functions.
- 2. The application uses both its own and third-party cookies.
- 3. The cookies used on the Application do not collect data that allows direct identification of the User. Data is obtained in an anonymised manner, except where the user consents to another form of processing.

§3 Purposes of cookies

- 1. Cookies are used in the Application for the following purposes:
 - Analytics and statistics cookies make it possible to analyse User activity in order to optimise the functions of the Application. For this purpose, Google Tag Manager and Google Analytics tools are used, which collect anonymous data on user behaviour.
 - **Storage of the User's session** cookies are necessary to remember the logged-in User and to enable the User to use the secure features of the Application.
 - **Monitoring and performance improvement** the cookies used by the Sentry tool allow us to monitor errors and ensure the stable operation of the Application by recording technical problems and improving their repair.

§4 Types of cookies used in the Application

1. **Session cookies** – stored temporarily on the User's device and deleted when the browser is closed or the session on the Application ends. These cookies are necessary for the proper functioning of the Application and to enable secure log-in.

2. **Persistent cookies** – stored on the User's device for a specific period of time or until they are deleted by the User. These cookies enable recognition of you when you use the Application again and support analytical functions.

§5 Cookie management

- 1. The user has the option of managing cookies through the settings of their web browser or through the configuration of their device. The User may block or delete cookies at any time, but this may affect the Application and restrict access to some of its functions.

§6 Third-party cookies

- 1. The Application uses cookies from third parties, in particular:
 - Google Tag Manager and Google Analytics used to collect statistical data about Users' behaviour on the Application. Google may process the data collected through these cookies in accordance with its Privacy Policy available at <u>https://policies.google.com/privacy</u>.
 - **Sentry** performance and error monitoring tool for Applications. Sentry processes data relating to the operation of the Application in accordance with the privacy policy available at https://sentry.io/privacy.
- 2. Information collected via third-party cookies is processed by these third parties in accordance with their privacy policies. The Application Administrator has no direct access to this data and is not responsible for the data processing rules of these entities.

§7 Changes to the cookie policy

The Administrator reserves the right to make changes to the Cookie Policy. Any changes will be published in the Application and on the website if the Application uses a separate information site. Your continued use of the Application following the implementation of the changes to the Cookie Policy implies your acceptance of these changes.
